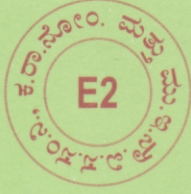

- 4. When are provide the nurse or attender (Rs. _____ one month salary will be collected ad advance payment.**
- 5. Customer must wait till the replacement of the candidate. (if need)**
- 6. If in case customer misbehaves with nurse or attender (CHAITHANYA FHNS) has rights to take legal actions.**
- 7. After getting registration need 3 days to recruit the candidate.**
- 8. We have all rights to change service charge without prior intimation.**
- 9. CHAITHANYA FHNS is not responsible for any type of Theft, Damages, Loss and will not responsible (In case of any requirement Identity and address proof of the Staff will be provided to the customers).**
